- (i) Tree price, excluding royalty fee, to be negotiated directly between the grower and the nursery. Tree deposits to nursery at confirmation of order.
- (ii) A minimum of 3 ha should be planted.
- (iii) Fees payable on confirmed orders (Excluding VAT).
  - R1100/ha entry fee upfront in order to secure hectare allocation.
  - Royalty fee of R7.00 per tree, payable, prior to release of budwood for budding or top-working.
  - Production royalty: R10.00 per tree, per year paid only in years 3,4 & 5.
  - Trademark royalty: €0.05 per carton of exported fruit.
  - Local market: R0.10 / kg of fruit sold under the trademark.
- (iv) All fruit to be marketed via licensed exporters to licensed channels.
- (v) Cartons to be identifiable with Grupotec traceability system (Grupotec license fee excluded in carton royalty)
- (vi) **Every effort is made in ensuring trueness-to-type but extensive evaluation of these cultivars has not been possible yet under South African conditions.**

I, \_\_\_\_\_ herewith warrant that I am duly authorised to sign this document and to give **the following undertakings**, namely that I will:

- a) enter into a non-propagation and Supply Agreement prior to receipt of trees
- b) join the Grower Group; and
- c) pay the applicable royalties (per tree and fruit) upon account rendered within 7 (seven) days of written request to do so; and; I acknowledge that the ownership of the relevant plants will not vest in me or the owner, or will not be delivered to me or the owner until the aforesaid documents are signed.
- d) growers' are expected to supply the detail of the orchard identification namely, name and GPS coordinates on completion of planting.
